Angelica Alfonso Cortes (aka Sydney Sanz), 17, is currently, illegally in the hands of Coastline Church in San Diego. She has been actively removed from her mother without court orders. The father has a history of trying to traffic his daughter and lives in Florida with no known contact.

The chronological details of the case are as follows:

March 8, 2002, Clara Cortes was nine months pregnant, living in Florida with Alfonso. His abusive behavior suggested his interest in his daughter was for child trafficking. Under the counsel of an attorney Clara fled Florida to reunite with family in Illinois.

Days later the baby, Angelica (aka Sydney), was born in Illinois. Alfonso followed to Illinois, had his name added to the birth certificate and forced the couple to reunite.

For the next 16 months the couple remained together. Alfonso threatened suicide and made other violent comments to keep the couple united. She was shown guns, rope and weapons while making threatening comments. Alfonso also drugged Clara.

Then Clara fled with Sydney with the help of domestic shelters. For the next few months she changed addresses multiple times. Eventually with the help of a doctor, she moved to Carlsbad, CA. She lived there from 2004 to 2016 with little incident under the name Sandra Sanz.

Clara became involved with the Coastline Church approximately seven years ago. It became clear to Clara that trafficking was occurring within the church. (Ages are approximate)

- Aaron Jayne (40), the leading Pastor at the church openly indicated a sexual addiction
- Larry McNamer (60s), the church media director, wrote a statement describing inappropriate behavior within the church specifically regarding Sydney, Tim Shaw and Steve Krajenka (60). SEE EXHIBIT H.
- Tim Shaw (40) began an aggressive campaign to lure Sydney. On Feb 10th, 2018, Sydney was found alone with Tim Shaw, Sydney was in the dark on the floor of the church, Sydney had bruises next day. Sydney was taking selfies of her bruises and hiding photos in her lap top.
- Erin Correa, with a history of manslaughter and drugging children, was given volunteer
 opportunities at the church. The church told him he was not allowed near the children's
 building, yet he had access to Sydney. She was terrified of him.
- Aaron Marks (30) sent inappropriate photos, called Sydney evenings and invited himself over
- Ernesto Luque (50's), church security director, met with Clara on five occasions claiming to have a budget of 50K to help her on this case, stated was in shadow govt., displayed photos and stated that he works for Hillary Clinton. In fact, he set-up Clara in building a case that she is insane to take Sydney from her.

In 2016, Sydney made multiple comments eluding to the fact she would no longer be living with her mother. Sydney mentioned on several occasions that Tim Shaw and Amanda Jayne directed Sydney to take them evidence to use against Clara to take Sydney from her mother.

In April 2018, the Malouf's – members of the church – kidnapped Sydney for a period of 5-6 weeks. The Del Mar San Diego police, Carlsbad police and Oceanside police were approached but would not accept evidence.

After 5-6 weeks she reappeared completely changed: anxiety, panic attacks, wanted to carry mace, making various inappropriate sexual comments, commenting about trafficking. She exhibited parental alienation.

Nov 25th, 2018 – A complaint was filed with both the San Diego DA and San Diego County Sherriff's Department with no consequences. Clara believes that the church and local law enforcement in the area are connected in a larger trafficking ring.

On December 8th, 2018, Clara wrote a letter specifically requesting that the church remove her child from all church activities, cease all contact and that restraining orders would be made against the church.

On December 12, 2018, Church membership and the Carlsbad Police refused to allow Clara access to her own daughter under the premise that her daughter was "afraid" because her mom was mentally ill. Church members involved in the incident included Tim Shaw, Ed White, Amanda Jane, and Ernesto Luque. On December 17th, Clara filed restraining orders against four staff members of the church.

To date, for one year, Clara has been unable to reunite with her daughter.

Local enforcement options have been exhausted making handling this situation impossible within San Diego. Law enforcement refuses to interview and look at evidence gathered by the mother and Angelica herself.

On December 27th, 2018 people within the church convinced her daughter to file a restraining order against her mother.

As of today:

- Clara and Alfonso are technically married, San Diego court informed Clara that she could not get divorced, that she needed an attorney. Separated 15 ½ years no contact, Sydney is 17 only child (turns 18 in March)
- Alfonso is believed to be living in Florida with no parental interest in daughter Sydney, apparently he flew in, signed her over to people associated to the church and returned to Miami, FLA. From the moment that Clara was pregnant, he informed Clara that the child was not hers and that at least he did something for society. He is believed to be homosexual. It is believed that the child was sold prior to her birth to trafficking in Miami, FLA.
- Sydney is being raised by members of the church; the church will not disclose her living arrangement to the mother.
- Local law enforcement has been ineffective
- There is no known court documentation regarding custody making Clara the only active parent in Sydney's life; and completed blocked from her child by a church organization

Great physical, emotional and psychological damage is occurring and only an immediate response with allow the safe return of Sydney before her 18th birthday (March 2020) when Clara will be less able to exert her parental influence. It is believed that there are other children and women involved in this sexual abuse that stems from Miami, Chicago, and San Diego. Facts Supporting Permanent Restraining Orders Against

- 1. A Signed Complaint ("The Complaint"), addressed to San Diego County District Attorney Summer Stephan, has been filed with the San Diego County Sheriff's Department and received by Watch Commander, Sergeant Brett Garrett at the Encinitas, California Sheriff's Substation, on Sunday, November 25th, 2018, by myself Clarita Cortes Alfonso (also known as "Sandra Sanz"), the Mother of Angelica Cortes Alfonso, my Minor Child Daughter, age 16 years, (also known as "Sydney Sanz"), describing abuses of my Daughter over several years, from her age of 13 years to the present, by one or more Members of the Coastline Church in Carlsbad, California (herein named as "Coastline Church", "Coastline", or "The Church"), during both Myself and My Daughter's attendance as Congregation Members at Coastline. Please see text of The Complaint which documents sexual, drug, physical & emotional abuses by the Pastoral Staff and/or other Members of Coastline.
- 2. The above filing of The Complaint with the San Diego County Sheriff's Department, was accompanied by Evidence in the form of Photo Copies of Smart Phone Text Messages transmitted by Max VanLoan ("Mr. VanLoan"), an Adult Male Member of Coastline Church, to my Minor Daughter's Smart Phone, expressing Mr. VanLoan's relief that my Daughter is not pregnant after missing her monthly period for several months.
- 3. I believe Mr. VanLoan, an Adult Male Member of Coastline Church,

is having sex with my Minor Daughter - which is a crime of Statutory Rape. EX HIBITC

- 4. In the Text Messages described above in paragraph 2., Mr. VanLoan texts Faith-Based Suggestions to my Minor Daughter, influencing her to participate in Immoral and Unlawful Activities. His influence is further reprehensible, because My Daughter is led to believe by Mr. VanLoan, that his actions are within bounds of the moral standards of our Christian faith something which is patently false because sexual and unlawful activities with children such as My Minor Daughter, are forbidden to us as Christians and as law abiding citizens. Yet Mr. VanLoan remains a Member in good standing of Coastline Church, the Leadership of which Church, numbering several individuals, including those each named in this document, have wholly refused to address my many, ongoing requests to The Church for relief in this circumstance over the last year and more. Instead, The Church Leadership, including those named herein, have undertaken an ongoing campaign of harassment of myself and my family, rather than deal with loose, immoral, unsatisfactory and illegal behaviors emanating from their Ministry and their Church Membership. Extincit
- 5. In the Photocopied Text Message Evidence, Mr. VanLoan communicates further with My Minor Daughter about the importance of Members of Coastline Church not knowing my Daughter is attending Church activities while High on Drugs. Therefore,

I believe Mr. VanLoan is giving Drugs to my Minor Daughter. EXHIGITE

- 6. The North County Division of the San Diego County Superior Court is in receipt of the Text Message Photo Evidence against Mr. VanLoan mentioned above, in paragraphs 2 through 5.
- 7. The North County Court has issued a Temporary Restraining Order (TRO) against Mr. VanLoan, an Adult Male Member of Coastline Church, enjoining him from further contact with myself or my Minor Daughter. Nevertheless, Mr. VanLoan, while thus far, avoiding service of process in this proceeding, with his family claiming him to be out of country and therefore out of the jurisdiction which has prosecutorial authority over statutory rape and other crimes in San Diego County in violation of conditions of the TRO may be continuing to see and/or communicate in person, by voice, or digitally with my Daughter, who has come under complete influence and control of Mr. VanLoan and several other Members of Coastline Church, as described below.

- 8. A former Long Term Subcontractor of Coastline Church, Mr. Larry McNamer ("Mr. McNamer") has written and signed a Statement, (herein referred to as "The Statement", or "Signed Statement") concurrently filed with The Complaint on Sunday, November 25th, 2018 with the San Diego County Sheriff's Department at the Encinitas Sheriff's Substation. Mr. McNamer's Statement alleges ongoing, irregular, inappropriate pastoral behaviors toward my Minor Daughter by the Worship Pastor of Coastline Church, Mr. Tim' Shaw ("Mr. Shaw"), over at least a two (2) year period, which independently corroborates allegations against the Worship Pastor & other Coastline Leadership Pastors in The Complaint.
- 9. Mr. McNamer is on business in New York, NY today on Friday, January 4th, 2019 and unable to attend this hearing. The Court can reach him telephonically. Mr. McNamer did however, previously accompany me to this Court, to offer his testimony in this matter from his place of business in Pine Valley, California on the original date of my filing a request for Restraining Orders against Members of Constline Church.
- 10. Mr. McNamer, a serious and credible witness, recites in his Signed Statement he presented several, ongoing verbal objections to the Worship Pastor of Coastline Church Mr. Shaw, about the Worship Pastor's behavior toward my Minor Daughter and that these objections were ignored.
- 11. Mr. McNamer recites in The Statement, he would, quote,
 - "...come back from lunch on Sundays, after second service and find all the lights in the worship center were off, Sydney would be laying on chairs with Tim's coat over her and they were the only two in the building," unquote.
- 12. Following his several verbal objections to behaviors of Mr. Shaw toward my Minor Daughter, Mr. McNamer, whose specific professional duties as Technical Director were accomplished apparently without criticism, was summoned to two (2) meetings with Worship Pastor Tim Shaw & the new Executive Pastor of Coastline Church, Mr. Steve Krajenka ("Mr. Krajenka") and in the first meeting he was encouraged to, quote, hang out and do life with the teenagers, unquote. After refusing this role, during the second meeting, Mr. McNamer's professional services to Coastline were terminated by Mr. Krajenka.
- 13. Mr. McNamer in his Signed Statement recited that during his first meeting with Mr. Shaw and Mr. Krajenka, he advised Executive Pastor Krajenka, quote,
 - "...as the senior pastor, I just have to let you know that there are some improper things going on behind the scenes in this worship team that are questionable at the very least," unquote.
- 14. Executive Pastor Krajenka has now recently departed Coastline Church.
- 15. As Mr. McNamer's technical services were always observed to be competent and professional in fact, he is well regarded nationally in his field the reason for his dismissal from Coastline Church must proceed from another cause. The only other available cause, given the facts at hand, is that Mr. McNamer refused to implicate himself in loose, inappropriate and questionable pastoral behaviors evinced by Mr. Shaw and encouraged by Mr. Krajenka.
- 16. Mr. McNamer goes on to recite in his Signed Statement, quote,

"Part of the issue for me, was that I was hearing Aaron [Lead Pastor Coastline Church, "Mr. Jayne"] making the comments, twice that I can remember, that he had a problem with sexual addiction. It was something that he tended to talk about and hammer on a lot, making me feel uncomfortable from the standpoint, that it sure seemed like it was a great way to put up a front that there was something more going on that we didn't know. Sandra's daughter, Sydney at the time for a 13-year-old girl, was a very smart individual. She was able to perform and play multiple instruments in an amazing fashion for her age. As everyone became aware of her talent, Tim was more and more adamant that she be there as much as possible, even with her own mom saying she couldn't be there on certain nights. Sydney was being given, on multiple occasions, water bottles by Tim that were opened when they were brought to her. There was a sudden onset of headaches, not feeling good, having to go lay down or her mom taking her home, leading a few of us that witnessed this, to believe that something was being put in her drink. As time went on, Sydney was becoming more and more rebellious against her mom's wishes about when she could be at church and when she needed to be at home. Starting just before I was let go, Tim was putting a lot of pressure on Sydney to stay at the church and that somebody would take her home and if they couldn't find anyone to do it, that she could spend the night at somebody's house," unquote.

17. On several occasions, *Mr. McNamer* saw *Mr. Shaw* taking my Minor Daughter home alone in his car. In The Statement, *Mr. McNamer* witnesses this behavior saying, quote,

"After rehearsals, during the week, Sydney, was being taken home by members of the team. When no one could step up and take her home, Tim gave her a ride without anyone else in the car. At one point, after this happened two or three times, I approached him and asked him why he was taking her home with no one else in the car and why he thought it was appropriate. He asked me where I was going with my thought process and I reminded him that he was a pastor and that just the suggestion of impropriety, whether it was true or not, certainly would matter in this day and age," unquote.

18. It is immensely troubling to me as a Mother, that my Daughter Sydney may have been given drugged liquids by, been alone for hours on end with, and been repeatedly taken home alone by, Mr. Tim Shaw, the Worship Pastor of Coastline Church in Carlsbad.

These facts are an Outrage to any Loving Parent, Congregation or Community.

19. On several occasions, the Security Director for Coastline Church, Ernesto Luque ("Mr. Luque") has displayed his handgun for me to see. I took these actions as threatening. Mr. Luque specifically told me, quote,

"I am the Trigger Puller, I am called at the end of a job to finish things," unquote.

- Mr. Luque told me the Lead Pastor of Coastline Church, Mr. Aaron Jayne had directed Mr. Luque to take care of our family's case. Pastor Jayne had previously advised me this was to occur and he was detailing Mr. Luque to the task.
- 20. Mr. Luque requested \$700 from me to do a background investigation about my Daughter's father, but never forwarded any results to me, despite reciting words to the effect of, 'I have a stack of papers about the investigation, which I haven't gone through yet.' Nor did he give me a receipt for the cost of the investigation, after my several requests.
- 21. Meanwhile, Mr. Luque asked me to work for him at his Security Consulting business. I believe Mr. Luque's several purposes in this entire charade of 'pastoral' exercise were,
- To discover the identity of my Daughter's father, from whom we fled under threat of abuse, over 14 years ago,
- To lay the groundwork for *Members of Coastline Church* to move to legally to take my Daughter from my care and legal custody, and
- To, in the process, impugn my credibility, as a Parent and Loving Mother to my Daughter of 16 years.
- 22. Thus instead of helping a family with a headstrong, emotionally vulnerable, teenage Daughter in spiritual and emotional crisis, Coastline Church has actively and programmatically sought to destroy our family actions which put the lie to their representation as being a 'Christian' Church in anything but name only. The only term that is apt, to describe such a circumstance when a religious organization's members espouse and band together under values promoting illicit things or illegalities is Cult,

Coastline Church is a Cult.

- 23. In The Complaint and independently in Mr. McNamer's Signed Statement, it is described that Ex-Convicts were employed as Leadership Members of Coastline Church. It is hard to imagine making these facts up.
- 24. In The Complaint, I note that one of the Ex-Convicts was allowed by Mr. Shaw to join the Coastline Worship Team, saying, quote,
- "Tim allowed Erin Correa, a man who was in prison for killing a 16 year old girl by overdosing her with heroin, to join the Worship Team (no trial period). He was not allowed to go near the children's building, but allowed to get near my child. Sydney was terrified of him?" unquote. WHIBIT I
- 25. I further describe in the Signed Complaint, quote,
 - "During this time, Aaron Marks, a member of the Worship Team, was behaving inappropriately with my child. He was communicating with her over Snap Chat, tapped her on her arms and shoulders, hugged her and sent a photo of himself coming out of the shower with a towel around his waist. He asked her if he could come over to our home to play cards with her at 11:30 PM. I approached the church staff (John Argus) the very next day that I became aware of the situation and received no immediate response to my inquiry or concerns," unquote. [4+ took & morths] [XIII]

and only after I wrote letter

26. With multiple occasions of sexual, drug related and other inappropriate or lewd behavior by several Members of Coastline Church toward my Minor Daughter, I deemed it unsafe for my Daughter to continue to attend further at Coastline and made repeated directions in person, by telephone and by Overnight & Registered Letter, (with return receipt requested) to the Leadership of Coastline, to leave myself and my Daughter alone, and

These directives were uniformly met with capricious disregard by the Leadership of Coastline Church.

- 27. San Diego County has enacted Ordinance No. 10045, 'RELATING TO CURFEWS FOR MINORS' requiring Minor Children to be in the custody of their Legal Guardians during Curfew Hours which are from 10 pm to 5 am during the week.
- 28. Ordinance No. 10045, requires in Section 35.103, entitled CURFEW RESTRICTIONS, that,
 - (a) It is unlawful for any minor to be present in any public place or on the premises of any establishment within the unincorporated area of the County of San Diego during curfew hours unaccompanied by a parent, guardian or responsible adult.
 - (d) Before taking any enforcement action under this section, a deputy sheriff shall determine the apparent offender's age and reason for being in a public place or on the premises of the establishment during curfew hours. If a minor is accompanied by an adult not the minor's parent or guardian, the deputy shall verify whether or not the person has authority from the parent or guardian to have care and custody of the minor.
- 29. The City of Carlsbad, California has adopted Municipal Code, Chapter 8.04, the "PARENTAL RESPONSIBILITY AND JUVENILE CRIME AND VICTIMIZATION PREVENTION LAW", which states,

8.04.010 Title and purpose.

The purpose of this chapter is:

- B. To protect juveniles, whose lack of maturity and experience renders them especially vulnerable to being victimized by older perpetrators of crime and to becoming participants in unlawful activities...
- C. To foster and strengthen parental responsibility for juveniles.

8.04.020 Definitions.

"Curfew hours" means the hours between 11:00 pm and 5:00 am each day.

8.04.030 Prohibition - Juvenile.

...it is unlawful for any juvenile to be present in any public place during curfew hours.

8.04.040 Prohibition - Adult.

...it is unlawful for a parent, guardian or responsible adult to knowingly, or by insufficient control, permit a juvenile to be present in any public place during curfew hours.

- 30. No Adult Member of Coastline Church has ever been given authority or responsibility by me, to be in custody of my Minor Daughter. Not Ever. Thus, the Leadership of Coastline Church while on multiple occasions keeping my Daughter at The Church into curfew hours, have actively violated Municipal and County Statutes, as recited above, in addition to my directives to them, as my Daughter's natural mother and legal guardian.
- 31. Sydney is advanced intellectually, but like me, is very much interested in pleasing others and thus, through 'lack of maturity and experience, has been rendered especially vulnerable to being victimized by older perpetrators of crime and to becoming a participant in unlawful activities.' It is heart breaking to me that my Daughter has been so rendered and abused.
- 32. Nonetheless, my Minor Daughter Sydney was at Coastline Church again on Wednesday night, December 12th, 2018, past the curfew hour of 10 pm and on into the morning at 1 am, on Thursday, December 13th, 2018 without my permission in direct violation of San Diego County and City of Carlsbad Curfew Restrictions for Minors after Coastline Church had already been in receipt of an Overnight & Registered Letter from me, as Natural Mother & Legal Guardian of my Minor Daughter, two days before, on Tuesday, December 11th, 2018, directing Coastline Church to cease all contact with our family. On this occasion, a Trustee of Coastline Church, Mr. Ed White ("Mr. White") was on The Church grounds with my Minor Daughter in violation of





his Curfew Responsibilities to minors and to My Minor Daughter - having summoned Carlsbad Police to The Church to take my Daughter into custody, without my consent, to be remanded to custody of Child Protective Services (CPS). Naturally, any chance of our family having a joyous Season together, Celebrating the Birth of Our Savior Jesus Christ was dashed in this episode of civil and police overreach. As Coastline Trustee, Mr. White has refused to answer the allegations contained in The Complaint and The Statement.

- 33. This latest occasion of Coastline Church's misbehavior, with respect to my Daughter's presence at Coastline, is just one, in an ongoing series of deliberate violations of my specific directions to the Coastline Leadership to leave us alone. In fact, fearing legal reprisal for the serious breaches of pastoral care by Members of Coastline, Leadership and Members of The Church have become a Cult and have thoroughly co-opted My Daughter Sydney into sexual, drug, mental, emotional and physical abuse. Consequently, I have now suffered issue of a Restraining Order by Sydney against me, which can only have been orchestrated by the Leadership of Coastline Church and which takes on the character of a 'Preemptive Strike' and 'Damage Control' in the face of now public filings with enforcement agencies, by credible parties, that allege something is quite amiss at Coastline Church. Sydney's comments to me concerning 'trafficking' indicate she is absorbing seriously immoral values, through association with her primary peer group, consisting of Members at Coastline Church. A bright child, who was home schooled by me, Sydney has become progressively more rebellious and uncontrollable, since interacting with Coastline Church Members and getting caught up in their drug use. Photos of Sydney at her high school graduation, show her with dilated pupils, pasty, pale, clammy complexion and a far off, lolling, dreamy look. Sydney was high on drugs. In Christian forbearance, I have repeatedly directed The Church to release my Daughter from their grip without effect. It is heart breaking to see her in such danger of abuse, each and every day she is out of my proper care as her natural mother, who loves her dearly and who has provided a good life for Sydney, all of her years, while she is being groomed by these Coastline people for dangerous purposes.
- 34. The North County Court is in receipt of Evidence Photo Copies of Scratches, Bruises on her face and "Hickeys" on Sydney's neck. My Daughter is not on this Earth to function as a sexual plaything to be used by Members of Coastline Church or anyone else. I believe my child has been sexually and mentally abused by members of Coastline Church, certainly including Max VanLoan and possibly Pastor Time Shaw and others. I have observed inordinate increase in the use of tampons by my Daughter during this period and what may be sexual issue of fluids on her underwear and clothing, which have been retained as evidence.
- 35. Carlsbad Police Department Corporal Griggs ("Cpl. Griggs"), acting as Watch Commander, interviewed my Daughter Sydney at Coastline Church that early Thursday morning of December 13th, 2018 and reported to me on that occasion in person, again past curfew while I was at Coastline Church, desperately trying to retrieve my Daughter that my Daughter, in the interview, described no instance of abuse or neglect at home, no justification whatsoever, for removing Sydney from my custody as her loving mother and legal guardian, yet nevertheless Cpl. Griggs was taking Sydney to Child Protective Services (CPS) for custody anyway under the full orchestration & complicity of The Church Leadership including Mr. White, who was personally present and acted with full authority of Coastline Church on that occasion. Thus, both Coastline Church and Cpl. Griggs of the Carlsbad Police are guilty of what amounts to Police sponsored kidnapping of my child from me. Again, Cpl. Griggs recited in that early morning darkness, when asked by him, my Daughter described no occasion of abuse or neglect at home no justification whatsoever, for removing Sydney from my custody as her loving mother and legal guardian.
- 36. I want my daughter Sydney back now and out of the clutches of this Cult. For weeks now, they have kept her hidden. This is just plain wrong. There is serious healing needed to return Sydney to the Delightful, Innocent and Loving Daughter she once was, before all this occurred. Max VanLoan, Pastor Aaron Jayne, Pastor Tim Shaw, Security Director Ernesto Luque and Trustee Ed White of Coastline Church have demonstrated open hostility to the integrity of our family behavior both un-Christian and unlawful. These people must be kept away from my Daughter and I, for our safety, and to afford us space to accomplish healing, with the Grace of God.

I believe that Senior Staff members Aaron Jayne (Senior Pastor), Tim Shaw (Worship Pastor), Ernest Luque (Security Director), Steve Krajenka (Executive Pastor), Amanda Jayne (Worship Leader), Eric and Allison Malouf and their son, Sam Stewart (Staff/Volunteer), Camden (Office Staff) and the youth group members, Savannah Duarte, and Max Van Loan are abusing my daughter, Sydney Sanz (aka Angelica Cortes) as stated below. In addition, Rick Jones (Worship Team Member), Erin Correa (Worship Team Volunteer), Aaron Marks (previous Worship Team Member), and John Argus (previous Drummer) at Coastline Church have been hurting my daughter physically, emotionally, psychologically and sexually. The following is a list of statements and incidents which have occurred with my daughter, myself, and pastors and staff members of Coastline Church while volunteering on the various teams. I am extremely concerned over the health and safety of my daughter and myself.

- 1. Larry McNamer (previous Media Director) informed me in late 2016 that Tim Shaw, the Worship Pastor, had been taking my child (13.5 years), out of the church and into his vehicle unaccompanied. He stated that he had witnessed it various times. He informed me that he approached Tim and informed him that it was inappropriate and they engaged in an argument. Tim informed Steve Krajenka, and the three met and Larry McNamer was relieved of his position at the church. He stated that he felt that I should know prior to him leaving. Please see Appendix 1
- 2. During this time, Aaron Marks, a member of the Worship Team was behaving inappropriately with my child. He was communicating with her over Snap Chat, tapped her on her arms and shoulders, hugged her and sent a photo of himself coming out of the shower with a towel around his waist. He asked her if he could come over to our home to play cards with her at 11:30 P.M. I approached the church staff (John Argus) the very next day that I became aware of the situation and received no immediate response to my inquiry or concerns. Please see Appendix 2
- 3. Tim allowed Erin Correa, a man who was in prison for killing a 16 year old girl by overdosing her with heroin, to join the Worship Team (no trial period). He was not allowed to go near the children's bldg., but allowed to get near my child. Sydney was terrified of him. I believe that Mr. Correa and Tim gave my daughter a cookie to give to me and I became very ill for approximately 9 days. Tim left town the next morning. My daughter informed me that she and Tim were telling people that I was schizophrenic because I thought that they had poisoned me. I never stated that they had poisoned me, simply that I became ill.
- 4. My daughter yelled at me. "You don't have a good job, you don't have a nice car, you don't own a house and you're too old; You can't even be trafficked!" I asked her to please tell me why she said that and what was going on, but she wouldn't. When I insisted, she would yell that I was crazy.
- 5. During the time that my daughter and I were being targeted, Aaron Jayne stated during his Sunday sermon several times, "I have a sexual addiction." During the weekend prior to them breaking my daughter, he was leaving to Israel. He again stated, "I have a sexual addiction. Today, I am here and tomorrow, I may not be." After he said this I believe that Camden, Tim and Mr. Luque finished breaking my daughter and destroying my credibility (weekend of February 9th, 10th and 11th)
- 6. February 9th, 2018, the Pastor from Highlands Church came to lead a marriage conference. My daughter informed me, "He has to notice me." I asked, "who" and she stated, "the pastor from Highlands," (approx. 68 years old). She repeated, "He has to notice me." "Why?" I asked again.

Surprised and a bit puzzled, she again stated, after some thought, "Umm, umm, because someday he could offer me a job?" It was unlike her character to say something like that. On February 10th, she demanded that I drop her off at church. I noticed Camden waiting at the upper level parking. He appeared to be giving us a serious and disdainful look. I decided to stop at the church after my training in Quickbooks. I found Sydney alone with Tim in the church, sitting on the floor in complete darkness wearing his jacket. When I questioned her in the car she completely lost it and began yelling and screaming. She called me a bitch for the first time. She was uncontrollable. I was completely frightened by her behavior. Later that evening, prior to getting ice cream, she stated, "I have to take a shower first because I stink and I am disgusting." She had never referred to herself that way. The next day, Sunday, February 11th, I looked at her face and noticed a huge black eye. She lied about how she acquired the black eye. I noticed that the Pastor from Highlands Church was speaking with Sydney on stage after the service.

- 7. On February 14th my daughter was invited to a Galentine's Day party at Jillian's house. I noticed that my daughter was coming downstairs from the second floor by herself in the dark. I questioned her and she denied it and became very upset. That night she spoke in her sleep stating, "Not gonna pretend that, that wasn't uncomfortable, but that's okay." Several weeks later she stated, "So what if I was coming from upstairs. It's none of your business if I was upstairs."
- 8. I discovered photos of her with swollen eyes in church and in different peoples' homes whom I did not recognize, as well as photos of her in cars with Italian or Latin men. She hid these photos on her iPad. On one of them she looked as if she was undressed from her top half, in the pro-presenter room at the church. Some photos look as if she is in shock.
- 9. There was a telephone call and a female yelled, "If you don't stop saying that your daughter is being trafficked, you will never see her again!"
- 10. On Wednesday, February 28th, 2018, during rehearsal, I noticed that Savannah Duarte, danced and moved sensually in front of Mr. Jones. Mr. Jones ignored her, and looked past her and at my daughter. I asked my daughter if she had noticed Savannah's behavior. I stated that she looked as if she was high on drugs. She began to yell at me stating, "Leave her alone, you don't understand! Leave her alone! Stop! You don't understand, leave her alone!" I again asked her what was going on but she would yell at me to be quiet and shut up!
- 11. March 9th, 2018, Sydney attended a birthday party for Savannah at the Malouf's. I picked her up and she stated that she was sick. She stated, "My hips hurt, my thighs hurt, my ankles hurt; I feel nauseous." That night she screamed as if she were in pain and agony. She yelled, "SAM, SAM, SAM, SAM," as if trying to get him to stop. Sam is the son of the Malouf's. She was sick for a week. She refused to speak to me about it. When I pressed her she would scream that I was crazy or schizophrenic and "Stop!"
- 12. Found a paper in my box in the garage that stated: "Go Back Sandra Sanz"
- 13. The night prior to my child running away she was crying when I went to pick her up from rehearsal. She stated that Tim was upset with her. The next morning as she finished packing, prior to leaving she whispered, "Mom, there's nothing wrong with you. There's nothing wrong with you, Mom." "Then why are you leaving, why are you helping them set me up?" I asked. She refused to respond. "I gotta go."
- 14. I believe that I have been threatened by Eric and Allison Malouf.
- 15. Max is having sex with a minor, giving drugs, and alcohol. I believe that the Malouf's are giving her more severe drugs. As a result, she developed an allergy that Allison claimed was caused by stress.







To Whom it May Concern:

This statement of fact is being done on November 3, 2018 having to do with several instances that happened at Coastline Church, involving Sandra Sanzs and her daughter Sydney as well as a few other people who were a part of the worship team and pastoral ship.

I was hired at Coastline by Aaron Jayne and Tim Shaw to be technical director, as a subcontractor but not as an employee. One of the observations that I had was that the worship leader. Tim, seemed to surround himself with a lot of young people. His demeanor around them was that of a father figure. Although something didn't seem quite right to me about the situation, I came in and did my job and left. But, as time went on, within a year and a half it started to be more noticeable that things that were happening weren't quite as covert as they were in the beginning. After rehearsals, during the week, Sandra's daughter, Sydney, was being taken home by members of the team. When no one could step up and take her home. Tim gave her a ride without anyone else in the car. At one point, after this happened two or three times, I approached him and asked him why he was taking her home with no one else in the car and why he thought it was appropriate. He asked me where I was going with my thought process and I reminded him that he was a pastor and that just the suggestion of impropriety, whether it was true or not, certainly would matter in this day and age. Roughly, about the same time that this was happening, I would come back from lunch on Sunday's after second service and find all the lights in the worship center were off; Sydney would be laying on chairs with Tim's coat over her and they were the only two in the building. By this time, Tim was getting a little tired of me mentioning what was happening, so I shut up about it and felt that I had said what I needed to say. A couple of weeks had past and coming into the church on a Sunday morning very early I was greeting by a new person whose name was lake. Jake seemed liked a very nice individual. Very pleasing. I started asking questions as to where lake came from and was told that he was just let out of prison and suddenly working at the church. Normally this wouldn't be that big a deal, since churches are in the business of forgiveness and working with people to give them second chances. But, as time went by, I finally found out after being told about Jake and his situation those in charge, Aaron and the people underneath him, were all very tight-lipped as to why he was in prison. By this time, Jake was already a very prominent person in the church there and was working up to be ordained and working around children. A couple weeks later, I was approached by, Steve, who had come to work for the church, who himself had left the store, the Gap as a senior advisor/manager and when he approached me he said he wanted to set up a meeting between Tim and I and him so that we could talk about the direction of my job and where the church was going. I agreed. The meeting was set up for two weeks later. By this time, Steve had been put in officially as the senior pastor and we, the people who were involved as leaders of the church, were told that he had quit The Gap. At the time, it seemed a little odd, but I went with it until I learned more or was given more information. At this point, we had the meeting with the three of us. The meeting went very rough from the get-go. Tim started by asking me about becoming more involved with the young people and the teams that I was dealing with. I answered Tim by saying, "Are you asking me to hang out with these people and in a phrase that this church uses, do life with them?" He responded in the affirmative. I shot back at him, "Tim, you understand that I am a 61-year-old man that works here as a sub-contractor and

is not a member of the church and I don't feel it's appropriate for some of my age to be hanging out with and doing life with a bunch of teenagers." This pretty much ended the meeting abruptly and Steve pulled me aside and began grilling me on why I couldn't be a part of these teenagers' lives. I told him again that I didn't feel it was appropriate and that I wasn't hired to be a children's pastor or mentor and that I had a specific job description as technical director to do what I was doing. Steve hesitantly said. okay, maybe we can talk a little later about this." At that point, I said, "Well, we could, but Steve, as the senior pastor, I just have to let you know that there are some improper things going on behind the scenes in this worship team that are questionable at the very least." Part of the Issue for me, was that I was hearing Aaron, the pastor of the church, making the comments, twice that I can remember, that he had a problem with sexual addiction. It was something that he tended to talk about and hammer on a lot making me feel uncomfortable from the standpoint, that it sure seemed like it was a great way to put up a front that there was something more going on that we didn't know. Sandra's daughter, Sydney at the time for a 13-year-old girl, was a very smart individual. She was able to perform and play multiple instruments in an amazing fashion for her age. As everyone became aware of her talent, Tim was more and more adamant that she be there as much as possible even with her own mom saying she couldn't be there on certain nights. Sydney was being given, on multiple occasions, water bottles by Tim that were opened when they were brought to her. There was a sudden onset of headaches, not feeling good, having to go lay down or her morn taking her home, leading a few of us that witnessed this to believe that something was being put in her drink. As time went on, Sydney was becoming more and more rebellious against her mom's wishes about when she could be at church and when she needed to be at home. Starting just before I was let go, Tim was putting a lot of pressure on Sydney to stay at the church and that somebody would take her home and if they couldn't find anyone to do it, that she could spend the night at somebody's house. As this was going on, I received a phone call from Steve saying that he wanted to meet with me at such and such a time, of which I said yes. When I got to the meeting, I was never told that Tim was going to be a part of the meeting and was fold that they were letting me go. My last day late flovember and in-between the time that I was told I was being let go and left, I was witnessing a lot of pressure being put on Sydney and Sandra was very concerned as to what was going on. I made it clear to Sandra that, from a legal standpoint, she is the mom and Sydney is the daughter. At any time, Sandra could walk in, take her daughter and leave. I always felt she needed to do this, but she was concerned about where she would live if she left the area because she had little income and felt she was being followed by members of the church. This is where my involvement ended. Please feel free to contact me if there are any questions.

Man Who Injected Teen With Heroin Sentenced

A man who injected heroin into his 16-year-old girlfriend, who died of a drug overdose hours later, was sentenced Wednesday to-six-years-in-state prison.

Erin Patrick Correa, 19, pleaded guilty July 27 to involuntary manslaughter and furnishing drugs to a minor.

The defendant was initially charged with murder, but was allowed to plead guilty to the lesser charges when it was determined that Dana Hooter had low levels of heroin in her system when she died, said Deputy District Attorney Nicole Cooper.

The victim also had other drugs in her system -- which Correa did not provide -- at the time of death last Jan. 10, the prosecutor

in her pants. In my eyes, you raped my daughter. You don't deserve to live. You killed my kid."

Before he was sentenced, Correa apologized to Vitela and the victim's family.

"I'm sorry, you know," the defendant said. "I never really intended this to happen. I did love your daughter."

Correa, who had a history of heroin abuse, was staying at a sober living home when he met Hooter a few months before her death, the prosecutor said.

The night before Hooter died, Correa took a half-gram of heroin with him when he and his girlfriend went to her Golden Hill residence on F Street while her mother was at work, Cooper said.

The prosecutor said Hooter had never used heroin before. She said Correa injected a small amount of the drug into himself, then injected the victim with the remainder and they passed out.

Correa woke up, saw the victim foaming at the mouth and instinctively moved her limbs to see if she was all right, the prosecutor said.

The defendant decided Hooter was fine and went back to sleep, according to Cooper. When he woke up at 5:30 a.m., Hooter was dead.

Dear Above mentioned: I find it difficult to write this letter as it is of a very sensitive nature. I have never requested anything of my church, Coastline, nor have I had any problems or concerns with anyone prior to this incident.

I will proceed by simply stating the facts of the incidents as they occurred. Some of what has transpired took place while Pastor Tim was out ill, early this year. This incident should have been brought to your attention, but I still do not know if you are aware.

I monitor my daughter's phone activity every evening, as I was instructed to do at a Children's Technology Safety Seminar which I previously attended. One Friday evening, as I was checking my child's communications, the phone buzzed alerting that Mr. Aaron Marks sent a message requesting to talk on Snap Chat at 10:53 pm. The next morning, I questioned my child and informed her that it was not appropriate for a grown man to want to speak to a female child and especially late at night, without parental knowledge.

The next day, Saturday, I was working on my computer with my roommate, past 11:00 p.m. I allow my child to stay up late on occasion, on Saturday evenings. She ran into the dining room a bit startled, and stated, "mom, Mr. Aaron just asked if he could come over to my house to play cards with me. He is creeping me out." At this point, I was clearly very concerned and upset and I asked her to delete her Snap Chat account and stop following his family on Instagram, as I did. I instructed her to stay away from him. I had recently noticed on several occasions, while at church, that Mr. Marks would go up to my daughter and tap her on her shoulders or arms and tell her that she was it. I instructed her to inform him that he is not to touch her. I asked her who was in charge while Pastor Tim was away and she stated, John Argus. I informed her that, we were going to notify John on the following day, Sunday. know if you are aware.

That Sunday, we approached John Argus and she informed him. John stated, "That is not Okay." "I will talk to him." I assumed that John would discuss it with appropriate personnel. We waited to see if anyone would respond to our concerns, however no one did.

By the way, I do not know Mr. Aaron Marks, nor have I ever spoken with him. On Friday May 20th, 2016, John Argus telephoned requesting if Sydney would serve on the worship team on a particular Sunday. I confirmed and prior to ending our conversation, I asked him if he had spoken with Mr. Marks and if he ending our conversation, I asked him it he had spoken with Mr. Marks and it he had discussed the matter with Tim and appropriate personnel. He proceeded to inform me that he had forgotten. I proceeded to remind him once more of the incident and he recalled our previous conversation. He began by informing me that Mr. Marks is a very close friend of his and that "he is going through a lot right now," he stated that "he has a lot ofproblems because his wife is about to leave him and he is going to lose his family because he has a sexual addiction." He stated that "he has had many affairs with women that he meets online. He also stated that Pastor Aaron was involved in the situation. Having been formed of this "was alarmed, concerned and upset that I now believed that "chult ma! "ed himself over to my home with ulterior motives and "fally the wy child. John continued with comments about rially I by child. John continued with comments about and an informed him that I understood his concern for although in God's eyes, it is a sin to have mutual, consensual motives and . his concern fr his friend but a relations with a dult outside of marriage – when one targets a child, it is Criminal and it is called Pedophilia. He stated that he would take care of it and I asked him to speak with Tim, etc. I continued to wait for someone to contact me, but to no ávail. I believe the last Sunday in July (31st), after service, at the entrance of the church, Mr. Marks reached for my child and hugged her. I was a few feet behind her and gave him a very serious look and his wife saw me. It took all that was in me to not go up to him and tell him what was on my mind. She told me that she did not have the opportunity to reject his hug and that she did not return the hug. If John, Pastor Tim and Pastor Aaron would have spoken with him regarding this issue, he should have clearly stayed away from my child, unless he has no regard or respect for Authority.

This letter has been written long ago, and while waiting for a response, I have concerned about her and the noticed Cecily's pregnancy advancing and I was concerned about her and the baby, as this was no fault of hers. Then her baby went to be with our Lord. I don't think that there is ever going to be an easy time for this, however, I cannot continue to conceal our concerns and emotions any longer. I have also been informed that John Argus is leaving our church.
I studied psychology in college. I also did an extensive study on
Online child predators. I am aware of their approach, grooming techniques,
recidivism, etc., and am also aware of the law. I have spoken to several
professionals regarding this matter, including her doctors. They are all in
agreement that they believe that Mr. Marks had ill intentions toward my child. We have no intentions on leaving Our Church, as we have been here for almost four years and it has become my child's second home and the worship and media team are her family. My child has served loyally on the adult worship team since barely turning eleven. The team has become a vital part of her life, who she is and is becoming. She absolutely loves, respects and looks up to Pastor Aaron, Pastor Tim, Pastor Josh, Amanda, John, Cody, Kenaniah, Chelsea, Eric, Keashore and Dave. All of the men on the teams have always treated my child with respect and they have all been gentlemen when

dealing with her. They laugh, they joke, they have a good time and have never overstepped their boundaries. They are her big Brothers and Sisters. She wants nothing more than to be at our church. If she could, she'd live there! I, as a mother and a father to my child, want nothing more than what all of you want and need for your children; to be loved, respected, to feel safe in a nurturing environment where one can grow together and where we all gather with one common purpose, to reach the lost for Christ. My child is concerned that this letter might cause retaliation from the church and that she will be asked to leave the worship team and all of the people that she has come to love, respect and to call family. I have reassured her that this is NOT her fault and that this is a very sick person, she has done nothing wrong. I am also concerned for other children at our church being exposed to this behavior.

Dear Mr. Jayne,

A written complaint has been registered for child abuse, including sexual, physical and emotional abuse involving Coastline Church, staff and volunteers. There is a current ongoing investigation with the District Attorney's Office, the Department of Justice and the Encinitas Sheriff's Department.

On Sunday, December 1st, 2018, I spoke to you after the 5:00 p.m., service at Coastline Church. I directed you to please remove my daughter, Sydney Sanz from any and all of the teams, groups that she is associated with at Coastline Church. I stated my directive three separate times and you did not give me a definitive answer. The only response that I received from you was that, "I would pray about it." You have yet to comply.

I was informed that My daughter left our home to go to Coastline Church Friday, December 7th, 2018 at approximately 4:00 p.m., while I was at my place of employment. I went to Coastline Church that day and informed Tim Shaw, the Worship Pastor that I wanted my daughter to be removed from all teams and that I no longer wanted my daughter to have any association with Coastline Church. He avoided giving me a response nor acknowledgement. Tim informed me that he had not seen my daughter, but that he would try to find her. I asked Celeste G., Director of the Freedom Conference for you, Aaron. She stated that you were in a conference. Shortly thereafter, I noticed you chatting in the Green Room. I proceeded by informing Celeste that I had spoken to you last Sunday and had given you a directive as the parent and guardian of my daughter and that you had yet to comply. I proceeded to give her my direct instructions, again, that I did not want my daughter affiliated with Coastline Church, it's volunteers or members in any capacity, permanently.

At this time my daughter came outside and I politely informed her that we had to leave. She gathered her things from the Green Room and we left.

In addition, I attempted to contact you via the churches telephone today, Saturday, December 8^{th} , 2018. I am aware that it is a work day for Coastline personnel, the call went to voicemail and I again left my directive for you.

As a parent and guardian of my child who is a minor, I am giving Coastline Church authoritative instruction to disassociate entirely from my daughter, Sydney Sanz. I have made three attempts to acquire a response from you and staff, without success. This behavior is unacceptable to me and I am outraged at your deportment and that of your staff and volunteers. I would like to inform you that I will be filing a temporary restraining order, should you not comply.

- (7) Exercising First Amendment rights protected by the United States Constitution or going to or coming from activities involving an exercise of First Amendment rights.
 - (8) Emancipated pursuant to law.



(d) Before taking any enforcement action under this section, a deputy sheriff shall determine the apparent offender's age and reason for being in a public place or on the premises of the establishment during curfew hours. If a minor is accompanied by an adult not the minor's parent or guardian, the deputy shall verify whether or not the person has authority from the parent or guardian to have care and custody of the minor.



Section 2: Effective Date. This ordinance shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.

PASSED, APPROVED AND ADOPTED by the Board of Supervisors of the County of San Diego this 23rd day of March, 2010.


AN ORDINANCE AMENDING TITLE III, DIVISION 5, CHAPTER 1, <u>SECTION 35.103</u> OF THE COUNTY CODE OF REGULATORY ORDINANCES RELATING TO CURFEWS FOR MINORS

The Board of Supervisors of the County of San Diego ordains as follows:


Section 1: Title III, Division 5, Chapter 1, Section 35.103 of the San Diego County Code of Regulatory Ordinances is hereby amended to read as follows:

SEC. 35.103. CURFEW RESTRICTIONS.

- (a) It is unlawful for any minor to be present in any public place or on the premises of any establishment within the unincorporated area of the County of San Diego during curfew hours unaccompanied by a parent, guardian or responsible adult.
- (b) It is unlawful for any parent or guardian of a minor to knowingly or by insufficient control allow the minor to be present in any public place or on the premises of any establishment within the unincorporated area of the County of San Diego during curfew hours unaccompanied by a parent, guardian or responsible adult.
- (c) The following are exceptions to the curfew restrictions set forth under subsections (a) or (b) above, and shall not constitute a curfew violation when the minor is engaged in any of the following activities:
- (1) On an errand or traveling in connection with activities at the direction or with the permission of the minor's parent, guardian or responsible adult.
 - (2) In a motor vehicle involved in interstate travel.
- (3) Engaged in employment or educational activities, or going to or returning home from employment or educational activities.
 - (4) Involved in an emergency.
 - (5) On the sidewalk abutting the minor's residence.
- (6) Attending official school, religious or recreational activities supervised by one or more adults and sponsored by the County of San Diego, a civic organization or other similar entity that assumes responsibility for the minor or going to or returning home from official school, religious or other recreational


